Other experiences include working as Vice President, Human Resources for the Midwest Division of Pizza Hut, a division of PepsiCo.

She began her global Human Resources career at IBM where she held several roles during her ten years across all HR disciplines, supporting diverse businesses, in various major IBM US locations.
